Đại sứ quán Thụy Sĩ xin kính chào Bộ Ngoại giao nước Cộng hòa xã hội chủ nghĩa Việt Nam và trân trọng gửi tới quý Bộ thư mời Việt Nam cử cán bộ tham gia khóa học mang tên « *The Leadership in International Security Course (LISC)* » do Trung tâm chính sách an ninh Geneva (GCSP) tổ chức tại Thụy Sĩ từ ngày 06/10/2025 đến ngày 28/05/2026.

Nhờ hỗ trợ của Chính phủ Thụy Sĩ, học viên khóa học này **không phải trả học phí**. Thêm vào đó, ứng viên Việt Nam có thể nộp hồ sơ xin **học bổng**. Việc cấp học bổng (toàn phần hoặc một phần) sẽ không được cấp cho tất cả các ứng viên và được xét duyệt theo một quy trình có tính cạnh tranh cao nhằm giúp ứng viên chi trả chi phí sinh hoạt tại Geneva. Tuy nhiên, chi phí đi lại của ứng viên sẽ do nước cử đi chịu trách nhiệm.

Để đảm bảo cân bằng giới, mỗi quốc gia được đề nghị cử hai ứng viên, một nam và một nữ. Ứng viên được đề cử phải nộp hồ sơ xin học trực tuyến tại <https://tinyurl.com/app-LISC-2526> trước ngày thứ Hai, **02/06/2025**. Chỉ những hồ sơ hoàn thiện mới được xét duyệt. Đại sứ quán Thụy Sĩ tại Việt Nam kính đề nghị các Bộ và cơ quan thông báo cho Đại sứ quán trước thời hạn trên nếu có ứng viên được cử đi.

With the support of the Swiss Confederation, the course is **free of tuition fees**. In addition, Vietnamese candidates are eligible to apply for a **scholarship**. Scholarship attribution (full or partial) is not automatic but based on a competitive review process. The purpose of the scholarship is to help cover living expenses and accommodation in Geneva. However, travel costs are the responsibility of the sending government.

To ensure gender parity in course participation, each country is asked to nominate at least two candidates, one female and one male. Nominated candidates are invited to **apply online** at <https://tinyurl.com/app-LISC-2526> by **Monday 2 June 2025**. Only complete applications will be considered. The Embassy of Switzerland in Viet Nam would be grateful if the Ministries could also inform the Embassy of the Ministries' nominations (if any) by the deadline.

COURSE DESCRIPTION

The Leadership in International Security Course (LISC)

Rebuilding Trust and Resilience in International Security

06 October 2025 – 28 May 2026

The 40th edition of this eight-month international security course is designed to increase the knowledge and skills of high-performing professionals, who seek to enhance their career and engage in leadership positions in solving the world's most pressing security challenges.

The course targets individuals who will interact with international agencies engaged in security-related policy planning, political and military decision-making and practical implementation in a range of complex and interlinked security situations.

In addition to the LISC Certificate, the course also offers the opportunity to receive a [Master of Advanced Studies \(MAS\) in International Security](#), jointly run with the Global Studies Institute of the University of Geneva.

Course Objectives

The course is designed to advance the knowledge and skills of participants to prepare them for leadership roles in their institution, in particular by enabling them to:

- Strengthen their **leadership skill-set** within a multi-cultural and cross-sectoral environment,
- Enhance their ability to critically analyse the **evolving nature of security threats**,
- Assess the effectiveness of current policy responses and propose **sustainable alternatives**,
- Develop their **international network** to pursue collaborative and innovative solutions.

Course Methodology

The curriculum of the LISC is revised each year in order to incorporate recent international developments and provides an interactive and flexible approach to learning – the 'GCSP Way' combining the experience and knowledge of scholars, practitioners and participants.

Participants will be engaged through three pillars including classroom analysis, peer to peer networking, and individual skills enhancement:

- **Expert-led sessions on security policy and institutional visits:** Will provide a comprehensive and global overview of topics related to international security. The sessions are led by GCSP staff and highly qualified guest speakers, which will be complemented with visits to Geneva-based international organisations and on occasion briefings from high level staff.
- **Participant-led activities and skills enhancement:** Will improve professional performance through interactive and/or participant-led workshops and modules on topics including leadership, strategic communication, negotiation, politico-military cooperation, strategic foresight, policy memo writing and reporting, debates, analysis seminars, national security policy briefings, etc.
- **Community-building and networking:** Will promote dialogue, understanding and generate the opportunity to form a long-lasting international community of security policy professionals based on mutual trust and confidence.

A particular focus on **Leadership** is carried throughout the course in both substance and skills enhancement sessions, as part of the GCSP's [Geneva Leadership Alliance](#) to develop participants' **individual** and **collaborative leadership capacity** through theory and practice.

Teaching Staff

In order to develop the relationship between scholars, practitioners and participants, the LISC teaching staff includes GCSP's own international team composed of academics and practitioners with broad experience in security policy, diplomacy and/ or military affairs, as well as high-level experts (academics, government officials, representatives from international institutions, non-governmental organisations, civil society, and the private sector) from across the globe.

Admission Requirements

Participants should be dynamic and highly motivated to study issues of international security, in addition to demonstrating a clear potential for leadership. Additionally, certain specific criteria are required:

- Applicants should have a university degree or be serving officers (Advanced Military Staff Course completed).
- Applicants should be at a mid-career level and have a corresponding level of professional or academic experience in the field of international security. Post-graduate training and/or mission experience is an asset.
- Applicants should have an **excellent knowledge of spoken and written English**, the working language for the LISC. A deficit in language capabilities will hinder an applicant's involvement in the course and may lead to their ineligibility to participate.
- The LISC depends on the continuous full-time engagement and attendance of all participants in Geneva throughout the course.

Course Fees

The LISC is offered free of tuition fees as part of Switzerland's contribution to the Partnership for Peace.

Scholarship for Living Expenses and Accommodation

A limited number of partial and full scholarships are available to help cover living expenses and accommodation **in Geneva**. Scholarship attribution is **not automatic and is based on a competitive review process**. The GCSP will offer the available scholarships to the most qualified applicants, in accordance with the admission requirements.

The scholarship amount may vary between CHF 1'000 and CHF 2'500 per month throughout the course (8 months from October 2025 to May 2026). The scholarship is offered by Switzerland and other member states of the GCSP Foundation Council through the GCSP Global Scholarship Fund.

Applicants should please indicate if they wish to be considered for a scholarship, in their letter of motivation, and state why it is required.

Travel costs between the home country and Geneva are the responsibility of the respective sending government or organisation. Travel costs associated with LISC-organised learning events during the course are paid by the GCSP.

Assessment and Course Certificate

Participants are assessed based on their participation throughout the course and their performance in a number of specifically assigned activities and tasks. After successful completion of the course, participants will receive a Course Certificate from the GCSP, a [PfP Partnership Training and Education Centre \(PTEC\)](#), as well as an [ISO 9001 certified centre](#). A letter of assessment, outlining the participant's performance, will be provided to the sending institution.

Alumni Community

Upon graduation, participants become members of the GCSP Alumni network. This network of over 12'000 members from over 174 countries offers access to an online community, regular information on GCSP activities, as well as invitations to designated sessions together with LISC participants and other alumni, either locally or internationally. During these events participants are updated on current peace and security matters where they have the opportunity to meet and discuss important issues while building up their professional network.

Application Process

Your country is kindly asked to submit all nominations **Monday, 2 June 2025**. Please note that due to the lengthy visa requirements, we must insist on this deadline and advise that late applications will not be considered.

Candidates should apply for the course [here](#). Candidates will then receive an automated email requesting the following documents to complete the application file:

- A letter of motivation (max 800 words)
- A curriculum vitae
- Two letters of reference from superiors within the candidate's sending institution

The application process is highly competitive and is open to a maximum of 24 participants. Only the most qualified candidates will be accepted.

In addition to careful consideration of the admission requirements in its selection process, the GCSP also strives to ensure diversity in institutional representation, national origin, professional experience and educational/training background.

Particular emphasis is placed on gender parity. For this reason, your country is asked to nominate at least two candidates, **one female and one male**.

Please also note that former participants of the GCSP advanced courses (the International Training Course in Security Policy/LISC, the European Security Course, and the New Issues in Security Course) are not eligible to apply.

Annex 1:

Master of Advanced Studies in International Security (MAS)

The GCSP is delighted to announce that LISC participants have the opportunity to earn a **Master of Advanced Studies in International Security (MAS)** (60 ECTS credits). This MAS is jointly run by the [Geneva Centre for Security Policy](#) and the [Global Studies Institute \(GSI\)](#) of the University of Geneva – and is based upon the internationally recognised training expertise of GCSP's Leadership in International Security Course in addition to the long-standing academic expertise of the University of Geneva.

The MAS has a taught and a research component, in addition to the successful completion of the three LISC modules. The taught component consists of the successful completion of the LISC and participation in an additional module taught by the University which will be assessed by a written exam. The research component requires the completion of a research paper (10'000-12'000 words) on an agreed security-related topic, examined by oral defence.

The tuition fee for the MAS programme is **CHF 15'000**. Tuition scholarships may be available. Interested applicants, after having been accepted to the LISC, should contact the Coordinator (mas@gcsp.ch) if they wish to apply for the MAS. Acceptance into the programme is subject to a University of Geneva Admission Board evaluation.

Further inquiries can be addressed to mas@gcsp.ch. Generally, candidates complete their LISC application first, and if accepted then provide additional materials to apply for the MAS track.
