▼ Limit of application number per Country

There is **no limit** to the number of applications per country. However, we consider the continent during the selection process. This means your application competes with others from the same continent. The more people apply from your continent, the higher the competition rate.

▼ Duration of the Field Trip

After completing the online courses, participants will be invited to the field trip. They will **stay in Korea for 10-12 days**. Please note that the travel duration may differ by 1-2 days depending on the participants' flight schedule.

▼ Schedule of the Field Trip

Participants can choose from available schedules **in July or September**. We will conduct a survey to check availability and preference, and then assign participants to each group.

? Who Can Apply

▼ Eligibility Requirements

If you do not fulfill all the requirements below, unfortunately, you are not eligible for the program.

- Able to attend live streaming courses and travel to Korea
- Currently in-service or working as a leader, change agent, or facilitator in promoting global development or on G20 matters
 - **Eligible organizations:** Central/Local government, Public organizations, State-owned enterprises, International organizations, and Research institutes & Higher education institutions.
- Fluency in English
- Minimum of three years of work experience in the public sector
 - For example, if you worked at a private company for three years and now have been working at a public organization for two years, you are not eligible because your work experience related to the public sector is under three years.

▼ If you are residing in Korea

We do not accept applications from those who are staying in Korea, except from those working at their **national embassy in Korea**.

▼ If you have visited Korea before

To maximize the benefit of each training program supported by the Korean government or institutions, we do not accept applications from those who participated in similar training programs or were invited to Korea for conferences, forums, etc. **within the past four years**.

- If you are a currently enrolled student at KDI School, you are not eligible for the program.
- If you are a graduate of KDI School, you can apply for the program only if you graduated before 2020.

? How to Apply

▼ Basic Information

- Please log in to Gmail when you write an application. Then **you can save your application and keep writing afterward.** **The application is automatically saved.*
 - **When you 'submit' your application, you will receive a copy of it through your email written in your application.** If you receive that email, it means your application is successfully accepted.
 - **The Application deadline cannot be expanded.**
 - **A Recommendation letter submitted after the deadline will not be considered.**
 - **All documents must be in English.** If you can only submit it in another language, please attach an English-translated version together.
 - **Once you upload documents, you cannot delete them.** If you want to replace it, just upload a new one. We will look through all the documents submitted, so the latest version will be accepted as valid.
